



Foster Care Entrustment Agreement

I hereby state that I am the sole owner of the hereinafter described Siberian Husky and that there are no other parties that may have a legal interest in said Siberian Husky. I further certify that said Siberian Husky is in fact a full purebred Siberian Husky. I further state and affirm that said Siberian Husky has not maliciously, or not by accident, bitten any human being or animal other than as indicated herein. I further state and affirm that said Siberian Husky has no past or current medical problems or issues other than as indicated herein. I further state and affirm that said Siberian Husky is current for all vaccinations including for rabies.

I further state and affirm that I will be responsible for all costs incurred by the Rescue Program to foster and care for said Siberian Husky. Said costs shall include, but not be limited to, feeding said Siberian Husky, veterinary care, required medications (including heartworm and parasite preventatives), housing for said Siberian Husky, and any other expenses the Rescue Program deems necessary for the welfare of Said Siberian Husky. In addition, I agree to be responsible for any legal costs, including attorney's fees, incurred by the Rescue Program to enforce this paragraph.

Based upon the above representations I wish to have The Siberian Husky Club & Rescue of Southern New England foster, care for, and be responsible for the well being of said Siberian Husky until I am able to take said Siberian Husky back into my care.

I understand and agree that if I have not made full disclosure concerning any bites or medical issues, as affirmed hereabove, and problems arise after the surrender of said Siberian Husky, said Siberian Husky may be returned to me, and I shall be responsible for any costs to resolve any issues emanating from or caused by such nondisclosure. I further agree to hold the Rescue Program harmless and indemnify the Rescue Program for any damages resulting from said nondisclosure, including but not limited to being responsible for any legal costs, veterinary costs or other exposures caused by such nondisclosure.

I understand and agree that I am surrendering said Siberian Husky to the Rescue Program of my own free will and that such surrender and release does not constitute a sale. I further understand and agree that I will receive no money or other compensation as a result of surrendering said Siberian Husky.
